Dear President Metsola and Honorable Leaders of the Political Groups,

We are civil society organisations directly and individually impacted by extractive projects granted strategic status by the Commission on 25 March 2025.¹ Our letter is also signed by NGOs, law firms and formal and informal groups working on the rule of law, environmental protection, human rights, extractivism etc.. Together we count 230 signatories which in turn represent millions of citizens from 9 member states and beyond.

Since the Commission's Decision of 25 March 2025² several of the undersigned organisations submitted access to information requests,³ under our rights guaranteed by the European Union.⁴ Each is asking for the full applications⁵ for strategic status recognition; including additional documents as per Article 7(1) and Article 7(6) of Regulation (EU) 2024/1252 and a copy of the methodology used for assessing the applications received within the cut-off date of 22 August 2024.

We need access to this information to scrutinize whether the applications meet all legal requirements and when not, consider our onward options. These include internal review requests under Commission Decision (EU) 2023/748 of 11 April 2023⁶ which must be submitted within 8 weeks after the administrative act has been adopted or published in the Official Journal.⁷

While we are awaiting official responses to our requests, based on meetings with officials from DG GROW, it intends to refuse to make the requested information available, referring to exceptions including 'business-sensitive' information. Instead it would only publish short summaries as well as *consider* sharing UNFC submissions or assessments. We would argue that the involvement of

public money⁸ to finance commercial mines declared strategic as well as the overriding public interest in the disclosure of the requested information and our rights to access public and environmental information override these exemptions. We acknowledge that detailed subsurface and deposit data on critical minerals, as well as information withheld by a project owner from shareholders, may not be accessible. Yet, the applications and the detailed UNFC evaluations, and the respective evaluations by the Commission and external experts also include social and environmental assessments; including on greenhouse gas emissions and other expected emissions into the environment.

Earlier in 2024, several NGOs already requested documents on strategic projects from DG GROW. They were refused on the grounds of commercial interests and the still ongoing selection process. Confirmatory applications are pending with the Secretariat-General with several exceeding by far the time limits established by Article 8 (1) and (2) of Regulation (EU) 1049/2001.

The public's right to such information is firmly rooted in EU and international law, including the Aarhus Convention, Regulation (EC) No 1367/2006, and Directive 2003/4/EC, which clearly state that emissions-related data cannot be withheld on grounds of commercial confidentiality. This position has been upheld by the Court of Justice in Flachglas Torgau (C-204/09). Moreover, Article 42 of the European Charter of Fundamental Rights guarantees citizens the right to good administration and access to documents. Supporting transparency in these matters is not only a legal obligation, but a vital step in reinforcing democratic participation, institutional accountability, public trust in the EU and the European project as such. Ensuring public scrutiny of projects with significant environmental impact strengthens our democracy and our Union.

What's more, article 15 of the TFEU stipulates that "to promote good governance and ensure the participation of civil society, the Union institutions, bodies, offices and agencies shall conduct their work as openly as possible." The Treaty thus reaffirms the EU's commitment to the principles of transparency and openness, which are meant to channel the participation of civil society in EU governance because they lead to better decisions.

As the President of the European Parliament and Leaders of the Political Groups, you collectively represent an institution directly elected by EU citizens, that is supposed to represent the interests of the people. Numerous reports⁹ as well as resolutions passed in your house highlight that the EU's rule of law has been eroding. What worries us is that if the European Commission refuses to provide access to documents containing information that may impact the public interest, then the EU is in danger of further democratic backsliding or autocratization. If we look at certain countries, we see that when transparency, democratic processes and the rule of law are weakened to benefit poorly regulated sectors, such as noncompliant extractive projects, it

The status of a strategic project also ensures the possibility for regional and national authorities to make use of funding from the European Development Fund and Cohesion Fund to support the relevant project, in line with the new STEP Regulation. leads to inequality, environmental pollution, social unrest, and increased political risk. Typically the space for public contest and political participation in decision-making is restricted and the exercise of political power becomes more arbitrary and restrictive. Also in the interest of the urgent energy transition [that has our full backing] to combat climate change, Europe should not go down that road and work as openly as possible. It is in this spirit that we call on you to urgently use all means at your disposal to call on DG GROW to release the information requested under Regulation (EU) 1049/2001 and Regulation (EU) 1367/2006 of the European Parliament and of the Council.
